It has 4 aims for our work between 2020 and 2024.



Aim 1

To help get more legal protection for people's rights to things like:

- food
- housing
- health





To make sure that people follow human rights laws.



Aim 3

To get more people to know and understand human rights.




Aim 4

Our Annual Report for 2021 to 2022

This Annual Report tells you about our work from April 2021 to March 2022.



This year the UK Government wanted to change human rights laws in the UK.

We have been telling people how important it is to keep the Human Rights Act instead.



We worked on our Strategic Plan aims.



In September 2021 the Scottish Government started work on a new Human Rights Bill for Scotland.

We are very happy about this.



We supported organisations by giving advice about human rights.



We carried on helping to get an Action Plan for Justice happening.

This is for people who were **abused** when they were children in care, many years ago.



Abused means hurt or harmed.



We helped write a Review.

The Review was about what action happens after people die when they are in prison or in police cells.

The Cabinet Secretary for Justice agreed with our advice.



We worked with the Scottish Parliament to:

- make COVID-19 laws better
- train some of their members in human rights



The United Nations **Climate Change** Conference happened in Glasgow. It was also called COP26.



Climate change means how our world and weather are warming up too fast.



We helped to organise a human rights online event at the same time.

More than a hundred people joined online.

We talked about human rights and climate change.



We wrote a report for the United Nations Human Rights Council.


We called it Scotland's Human Rights Report Card.





We told them that these human rights still need to be made better in Scotland for lots of people, including:

- children who live in poverty
- people in prison



We looked closely at how the COVID-19 pandemic is making some human rights harder to get.

We told people in charge how to make sure that human rights are planned for in any future pandemics.



We did not have enough money or staff to use all our legal powers this year.



Our Chair Judith Robertson left.

Our new Chair is Ian Duddy.

He has worked as Head of Human Rights in a department at the Foreign Office.



We were very happy that the United Nations gave us the highest grade as a National Human Rights Institution.

It is the third time we have been given the highest grade.



This shows that other countries see us as:

- experts
- good at what we do
