1 Introduction

This report presents the findings of research on human rights related advice and advocacy services in Scotland. The research was undertaken by Iconic Consulting on behalf of the Scotlish Human Rights Commission (SHRC) and the Children and Young People's Commissioner for Scotland (CYPCS).

Background

SHRC was established in 2008 by the Scottish Commission for Human Rights Act 2006 (SCHRA). It is a public body funded by, but independent of, the Scottish Parliament. It is fully independent of the Scottish Government. The general duty of the Commission is to promote human rights and, in particular, to encourage best practice in relation to human rights. The SCHRA provides for the Commission to fulfil these duties through providing guidance, publications, awareness raising and research and by making recommendations for changes in law, policy and practice in Scotland, and through education and training. The SHRC is exploring the current Scottish human rights system to inform its new Strategic Plan 2024-28. As part of its Transition Strategy 2023-24 into its new Strategic Planning cycle, the SHRC is focusing on four key 'spotlight' areas. One of those spotlight projects is Access to Justice. The SHRC's Access to Justice project seeks to highlight the realities and barriers that exist in attempting to access justice in Scotland for potential human rights violations. To do so, the Commission plans to 'spotlight' the experiences of real people and their advisors and advocates in the context of prisons and social care, and will use the research on advice and advocacy services in Scotland to inform this work. The SHRC does not have the powers to provide advice to individuals, to provide a casework service, or to raise legal proceedings in its own name. This mapping exercise will also inform considerations about the potential development of the mandate of the SHRC via the process of incorporating human rights treaties into Scots Law through the new Human Rights Bill.

CYPCS was established by the Commissioner for Children and Young People (Scotland) Act 2003. The Commissioner is responsible for promoting and safeguarding the rights of all children and young people in Scotland, giving particular attention to the United Nations Convention on the Rights of the Child (UNCRC). The Commissioner has powers to review law, policy and practice and to take action to promote and protect rights. The Commissioner is fully independent of the Scottish Government. CYPCS operates an advice function, providing human rights advice and signposting to children, young people and adults via telephone and email. As part of the development of the Commissioner's new Strategic Plan 2024-28, and the office's preparations for incorporation of the UNCRC, the Commissioner wishes to establish what other sources of advice and representation are available to children and young people on human rights issues. This will allow the Commissioner to consider how to deploy the office's limited resources to best effect, and whether there is sufficient provision of advice/representation in particular policy or geographic areas. CYPCS define children as under 18.

Research

The objective of the research was to map advice (including legal advice) and advocacy services in Scotland in relation to key human rights issues.



At the outset of the study SHRC and CYPCS identified the key human rights issues as:

- Education including Additional Support Needs (ASN) and bullying
- Housing
- Poverty
- Social security / Benefits
- Health
- Mental Health
- Disability
- Social care
- Care system including foster / kinship / continuing care
- Civil justice including family law contact, residence, Children's Hearings System
- Criminal justice including victims
- Immigration / asylum
- Detention
- Equality / Discrimination
- Workers' rights
- Biometrics, Artificial Intelligence (AI) and privacy
- Freedom of expression

SHRC and SCPCS also identified the following information requirements for each service:

- Advice and advocacy support provided
- Human rights legislation covered
- Provision of human rights information
- Provision for children and young people
- Geographic coverage
- Number of enquiries and support provided
- Funding sources

The mapping exercise used the following categorisation for advice and advocacy support. The categories are not mutually exclusive.

- Advice General advice, providing information, signposting or referring to another organisation, and explaining technical terms or official documents (equivalent to Scottish National Standards for Information and Advice Providers Type I Accreditation).
- Casework Initial discussion with an individual about the issue and the possible options, followed by ongoing support for the individual to take action including help with letters or forms, referral to other sources of assistance and help negotiating with organisations (equivalent to Scottish National Standards for Information and Advice Providers Type II Accreditation).
- Advocacy Support for an individual to help them express their views and wishes to others, access their rights or services including supporting the individual or acting on their behalf at meetings about them.
- Legal representation A person who is an expert in law acting on behalf of an individual in a legal matter including representation of their case in court or tribunal.

The term service is used in this report to refer to the organisation or a specific service within an organisation providing advice or advocacy. The term support refers to type of assistance offered by each service i.e. advice, casework, advocacy and legal representation. So each service will have



between one and four support offerings.

Services were initially identified as potential providers of human rights related advice and advocacy support in Scotland. The following sources were utilised in this process:

- Key advice and advocacy services identified by SHRC and CYPCS which included Law Centres.
- Services accredited with the <u>Scottish National Standards for Information and Advice</u> Providers.
- Members of the Scottish Independent Advocacy Alliance.
- Extensive desk research by Iconic to identify providers similar to those identified from the above sources that could potentially deliver human rights related advice and advocacy services in Scotland.

The following important exclusions applied:

- Service providers unless the organisation specifically delivered advice or advocacy support for children, young people or adults.
- Services where advocacy was at a strategic or policy influencing level not advocating for individual children, young people or adults.

A pro-forma was developed to gather information from services. A copy of the pro-forma is shown in Appendix 1.

An email was sent to 189 services in January 2024 inviting them to take part in the research. This included emails to Citizens Advice Scotland and Scottish Women's Aid inviting them to respond on behalf of their networks which consisted of 59 Citizens Advice Bureaux (CABx) and 37 local Women's Aid groups. An email was also sent to Together (formerly Scottish Alliance for Children's Rights) and they subsequently distributed the pro-forma to their members. The email explained the purpose of the research, what information was being requested, and how the information would be used by Iconic and subsequently by SHRC and CYCPS. A link to the online pro-forma was included. The email also stated that a Word version of the form could be requested from Iconic who could also provide further assistance if required. Two reminder emails were sent in late January and early February. SHRC and CYPCS also contacted some services where they had a named contact, that had not responded by late February.

Four services replied stating they did not deliver human rights related advice and advocacy support. It is possible that other services did not respond because they too do not provide human rights related advice and advocacy support.

In total 68 responses were received, including three Word submissions. Two services responded twice and the duplicate responses have been discounted. The 66 responses represent a 35% response rate. The information provided by these services is presented in this report. It should be noted that services may have applied different interpretations when answering questions, for example, regarding legal representation.

In addition, the report includes information for a further 196 services that did not respond to the survey. This includes information on the 59 CABx and the 37 local Women's Aid groups. This imputed information is based on desk research for each service and survey responses from similar



providers. The source of information is clearly stated throughout the report. The following information is included for services that did not respond to the survey:

- Advice and or advocacy support
- Human rights issues covered (this is limited to the most obvious ones only)
- Geographic coverage
- Provision for children and young people.

The following information is not included for the services that did not respond to the survey:

- Human rights legislation covered
- Provision of human rights information
- Number of enquiries and support provided
- Funding sources.

During the analysis phase information on advice and advocacy support for children and young people was re-classified for all services. The categories initially used in the pro-forma were found to be ambiguous and services had interpreted them in different ways. Our re-classification involved a review of each service's pro-forma (where submitted) and their website. The following mutually exclusive categories were used:

- Children and young people focused Services where advice and advocacy is exclusively for children and young people, professionals supporting children and young people or parents/carers.
- Mixed focus Services where some but not all advice and advocacy is exclusively for children and young people, professionals supporting children and young people or parents/carers.
- Open Services providing advice and advocacy with no explicit age restrictions meaning
 it is accessible to children, young people and adults.
- Age restricted Services where advice and advocacy has minimum age restrictions meaning it is not accessible to some children or young people.

This report presents information on 262 human rights related advice and advocacy services.

It should be noted that the mapping exercise focused specifically on human rights related advice and advocacy services. The information in this report should not therefore be seen as a comprehensive record of all the issues they cover as some services, including the CABx, also provide advice and advocacy on other issues. The information imputed for the CABx network shows they cover all of the human rights issues identified by SHRC and CYPCS. This reflects the holistic advice provided by CABx. While every effort has been made to gather and present accurate information, it is possible there may be some gaps or inaccuracy in this report.

Presentation of findings

Appendix 2 lists the 262 human rights related advice and advocacy services in Scotland. For each service, information is included on the support provided, human rights issues covered, provision for children and young people, and geographic coverage. Survey responses are denoted with * next to the service name. In the Word version of this report, an Excel file is embedded at the end of Appendix 2 which, when opened, can be used to examine the information in more detail; double click the Excel icon to open the file. In the pdf version of this report, the Excel file is an attachment and can be opened from the Attachments panel .


In addition, the results of the mapping exercise are provided in two online maps. The maps show the support provided, human rights issues covered, provision for children and young people, and geographic coverage. Map 1 has optional layers that identify services that cover the following human rights issues: education; housing; poverty; social security / benefits; health; mental health; disability; social care; and the care system. Map 2 has optional layers that identify the remaining human rights issues, namely: civil justice; criminal justice; immigration / asylum; detention; equality / discrimination; workers' rights; biometrics, AI and privacy; and freedom of expression. The location shown is the postcode of each service's main address, including services with multiple offices, Scotland-wide services, and services with one office that operate in several areas. Five Scotland-wide services¹ have no address in Scotland and their location is shown on the maps in the centre of Scotland. The geographic coverage of each service is specified in the information box that appears by clicking on the service marker. The maps can be accessed by clicking on the links, or pasting the web addresses, shown below.

2 Advice and advocacy services

This chapter presents information on human rights related advice and advocacy services in Scotland. An overview is presented followed by a summary of provision for children and young people.

Overview

The mapping exercise identified 262 human rights related advice and advocacy services in Scotland. Of the 262 services, 217 provide advice (83%), 187 undertake casework (71%), 188 provide advocacy (72%) and 38 provide legal representation (15%).



In total 144 of the 262 services (55%) provide both advice and advocacy on human rights issues in Scotland. Only 31 services (13%) provide support across all four categories (advice, casework, advocacy and legal representation).

Provision for children and young people

Overall, the majority of human rights related advice and advocacy services in Scotland is accessible to children and young people. Only 51 services (19%) have an age restriction that prevents some children and young people from accessing services; the age restrictions vary by provider although the majority tend to be 16 or over. Some 178 services (68%) are open and accessible to children, young people or adults. A further 13 services (5%) are focused on children and young people, and 20 (8%) are mixed with some provision focused on children and young people. In total 211 human rights related advice and advocacy services in Scotland are accessible to children and young people (81%).

The table below shows the human rights related advice and advocacy services in Scotland broken down by their accessibility for children, young people and adults and the type of support they provide. Of the 13 services focused exclusively on children and young people, 12 provide advice, 7 undertake casework, 4 provide advocacy and only 1 provides legal representation.

It should be noted that age is not the only criterion for accessing services. Other important criteria include location (see chapter 4), circumstances such as experiencing or being at risk of homelessness, having a specific health condition or illness, being care-experienced, or identifying with the protected characteristics defined in the Equality Act 2010.




3 Human rights covered

This chapter focuses on the human rights issues covered by the advice and advocacy services in Scotland.

Overview

The human rights issues covered by the advice and advocacy services in Scotland are shown in the graph below. Mental health was the most common human rights issue covered (178 services) followed by housing (169), disability (167), health (165) and social security/benefits (160). At the other end of the scale, Biometrics, Al and privacy (61), Freedom of expression (73) and workers' rights (79) were the least common human rights issues covered by services.



Provision for children and young people

The table below shows the human rights issues covered broken down by provision for children, young people and adults. The table shows that advice and advocacy support on all the human rights issues was most commonly available from providers that were open to anyone irrespective of age.

Among the 13 services focused on children and young people, the most common human rights covered were housing, health, education and the care system. Seven of the 13 services covered these issues.

Human rights covered by advice and advocacy support provided

The following sections summarise the human rights issues covered broken down by the four support categories – advice, casework, advocacy, and legal representation. It highlights variation in the rankings of the human rights issues covered, and in the percentage of services in each category covering a specific human rights issue. However, care should be taken when interpreting these findings. The research identified which of the four supports each service provides and, separately, the human rights issues they cover. Where a service provides more than one type of support it is not necessarily the case that all the human rights issues they cover apply to the different types of support they provide. For example, services such as the CABx could provide advice on numerous human rights issues but their advocacy support (where provided) would be limited to a handful of human rights issues. The research would show the service provided advice and advocacy support and covered numerous human rights issues.

Advice

Housing was the most common human rights issue covered by the 217 advice services (73%), followed by social security / benefits (71%) and mental health (65%). Biometrics, AI & privacy was the least common issue covered (28%), followed by freedom of expressions (33%) and workers' rights (35%).

Casework

The human rights issues covered by the 187 casework services were broadly similar to the advice services. Housing was the most common human rights issue covered (81%), followed by social security / benefits (78%) and mental health (71%). Biometrics, AI & privacy was the least common issue covered (32%), followed by freedom of expressions (37%) and workers' rights (39%).

Advocacy

The human rights issues covered by the 188 advocacy services differed somewhat to the advice and casework services summarised above. The order differed and the percentage of services covering each human rights issues tended to be higher. Mental health was the most common human rights issue covered (95%), followed by housing (90%) and disability (89%). Biometrics, Al & privacy (32%), freedom of expressions (39%) and workers' rights (42%) were again the least common issues covered.

Legal representation

Differences in the human rights issues covered were also apparent among the 38 legal representation services. The most notable difference was the lower percentages of services covering each issue. Social security / benefits was the most common human rights issue covered (71%), followed by housing (50%) and disability (26%). None of the services provided legal representation on biometrics, AI & privacy or detention, and only one covered freedom of expression and criminal justice including victims.

Gaps in provision

The above analysis suggests there is limited advice and advocacy support in Scotland on the human rights issues of biometrics, AI & privacy, freedom of expression and workers' rights. It also suggests there is limited legal representation in general with only 38 services across Scotland, and specifically for human rights issues other than social security and housing. In addition, while the majority of services are open to people irrespective of their age, there is limited provision specifically for children and young people.




4 Geographic coverage

This chapter focuses on the geographic coverage of the advice and advocacy services in Scotland.


Overview

In total 60 human rights related advice and advocacy services operate Scotland-wide (25%) while 162 operate within a specific geographic area (75%).

There was some variation in geographic coverage by the type of advice and advocacy support provided. Legal representation had the highest proportion of Scotland-wide provision with 15 of 38 services (39%) operating nation-wide, followed by advice (28%), casework (19%) and advocacy (18%). The number of services by support type is shown in the graph below.



The availability of human rights related advice and advocacy services for children and young people across Scotland is shown in the graph below. Marked variation is evident. Some 9 out of 13 children and young people focused services were Scotland-wide (69%) compared to 35% for the mixed services, 24% for open services and only 12% for age restricted services.





The geographic spread of human rights related advice and advocacy services can be seen in the two maps referenced in chapter 1. A concentration of services is evident in the central belt. This partly reflects population levels. It also reflects the location of several services based in Edinburgh and Glasgow that operate Scotland-wide or in several areas across the country. The geographic coverage of each service is shown by clicking on their location marker.

Area specific services

Area specific services are spread across Scotland from Shetland to Dumfries and Galloway. All local authority areas had at least three advice and advocacy services. Some areas have many more services than others - this reflects population levels or area-based delivery models in locations such as Highland. A breakdown of the services by region and local authority is shown below.

The majority of the area specific services align with single local authority areas. There were two exceptions to this rule. The first was smaller-area services such as CABx in Glasgow e.g. Greater Pollok Citizens Advice Bureau. The second was services that span several local authorities such as Central Advocacy Partners which operates across the three local authorities of Forth Valley.

It should be noted that university student advice services were counted as area-specific and assigned to the local authority area where the institution is based. Although the majority of students are likely to reside in these areas, the services are available to students at the universities irrespective of where they live. These services are not available to all residents of the areas where the institution is based.

Gaps in provision

Based purely on geography, there are no obvious gaps or under-represented areas. However, services in rural areas may be more difficult to access in-person for some potential service users due to distance and the limited availability or cost of public transport. Telephone, video-conferencing and email communication are generally available as alternative means of communication, although video-conferencing can also be more problematic in some rural areas where speeds can be limited and satellite broadband provision can be affected by adverse weather conditions.



5 Human rights legislation, provision, funding and enquiries

This chapter focuses on human rights legislation covered, how human rights information is provided, funding sources, and enquiries. The information comes from the 66 services that responded to the survey. As such the information should be interpreted with caution as a snapshot rather than a statistically significant representation of human rights related advice and advocacy services in Scotland.

Legislation


The survey provided useful insight on the human rights legislation covered by the advice and advocacy services in Scotland. It showed that approximately a fifth of the services provide advice on domestic law. It also showed approximately a quarter provide advice on the Human Rights Act 1998 and a similar proportion on human rights treaties such as the UNCRC or United Nations Convention on the Rights of Persons with Disabilities (UNCRPD).

The survey also found that 1 in 10 services provide advice on all three forms of legislation i.e. domestic law, the Human Rights Act 1998 and human rights treaties.

Provision

The survey asked services how they provide information on human rights issues. The most frequent way was through in-house generalist advisors/staff (68% of services). Relatively few services have in-house human rights experts (9%) or legally qualified advisors (8%). In contrast, half refer to external legally qualified advisors or external human rights experts (42%).





Funding

The survey provided an insight into the funding of human rights related advice and advocacy services in Scotland. It showed that almost three quarters of services received funding from charitable trusts or other sources (73%). It also showed that approximately half of services received funding from local authorities (52%) and a similar proportion received funding from the Scottish Government (50%).

The table below shows the mix of these three funding sources among human rights related advice and advocacy services in Scotland. It shows almost a quarter of services (24%) received funding from all three sources. A similar proportion (26%) are reliant on charitable trusts and other funds as they are not funded by the Scottish Government or local authorities. Some 6% of services received only Scottish Government funding.

Number of enquiries and those supported

Half of the organisations that responded to the survey provided information on the annual number of human rights related enquiries they received and how many of them were supported. Several of these organisations explained the numbers provided were estimates as they did not specifically record enquiries as human rights related. For example, one service reported 10,500 enquiries and explained "arguably all of our work focuses on human rights issues", based on the fact that all service users "suffer from stigma and discrimination". The information in this section should



therefore be interpreted with caution. The information is presented anonymously as several services requested this.

The number of human rights related enquiries ranged from the 10,500 to 2. The range reflects the diversity of human rights advocacy and advice services.

As shown above, some services reported they did not support all human rights related enquiries they received. Their explanations of why showed the main reasons were restrictions on who they can support, limited capacity or not having the requisite expertise.

6 Conclusions

This research has identified 262 human rights related advice and advocacy services in Scotland and gathered information on the support they provide. Based on extensive desk research and a survey of providers, the findings will help inform the work of the Scottish Human Rights Commission and the Children and Young People's Commissioner Scotland.

The research established that the majority of services provide advice (83%), undertake casework (71%), or provide advocacy (72%) on human rights issues. Relatively few services - 38 in total (15%) - provide legal representation on human rights issues. In addition, only 13% of services provide support across all four categories (advice, casework, advocacy and legal representation).

Overall, human rights related advice and advocacy services in Scotland are accessible to children and young people. Only 1 in 5 services have an age restriction that prevents some children and young people from accessing support. However, only 13 services (5%) focus exclusively on children and young people, professionals supporting children and young people or parents/carers. Approximately two thirds of services are open to anyone irrespective of their age.

The human rights issues covered by the advice and advocacy services in Scotland varied markedly. The most common human rights issue covered were mental health (178 services), housing (169), disability (167), health (165) and social security/benefits (160). However, far fewer services covered biometrics, AI & privacy (61), freedom of expression (73) and workers' rights (79). Sources of support on these issues, particularly, in-depth support will be even more limited than these numbers suggest. The 59 CABx cover all of the human rights issues as part of the holistic advice they provide however their support on biometrics, AI & privacy and freedom of expression is likely to be limited, compared for example to social security / benefits and poverty.

The research established that three quarters of services operate within a specific geographic area and a quarter operate Scotland-wide. However, there was some variation in geographic coverage by the type of advice and advocacy support provided. Legal representation had the highest proportion of Scotland-wide provision (39%), followed by advice (28%), casework (19%) and advocacy (18%). It was also noteworthy that two thirds of services focused exclusively on children and young people operate Scotland-wide compared to one third for the mixed services, a quarter for open services and only 1 in 10 for age restricted services. Area specific services are spread across Scotland with all local authority areas having at least three human rights related advice and advocacy services, although some have many more. Based purely on geography, the research did not identify any obvious gaps or under-represented areas. Additional challenges accessing services in rural areas were noted.

The survey provided additional information on the human rights legislation covered, how human rights information is provided, funding sources, and enquiries. However, the findings should be interpreted with caution as they are based on responses from 66 services. Nonetheless, the survey found that a fifth of services cover domestic law, a quarter cover the Human Rights Act 1998 and a similar proportion cover human rights treaties such as the UNCRC or UNCRPD. The most frequent way services provide support is through in-house generalist advisors/staff (68% of services), as well as by referring to external legally qualified advisors (50%) or external human rights experts



(42%). Relatively few services have in-house human rights experts (9%) or legally qualified advisors (8%). A limited number of services provided information on the number of enquiries they receive and the number of those supported, and when they did provide the information they tended to stress it was estimates as they did not specifically record enquiries as human rights related. Of the services that provided the information, the number of enquiries ranged from 10,500 to 2. Services that reported they did not support all human rights related enquiries explained this was due to restrictions on who they can support, limited capacity or not having the requisite expertise.
